RULES AND REGULATIONS:

- 1. Must have signed and dated this consent and release form.
- 2. Must have a valid climbing card or be in a group session.
- 3. There must be an authorized Gravity Rock Wall supervisor present.
- 4. Must wear and use approved safety and climbing equipment which includes: helmets, harnesses, ropes, and all accessories. This includes spotters who are present and ready on challenge courses.
- 5. Must wear shoes.
- 6. Must have your equipment and knots checked by the supervisor prior to climbing or belaying.
- 7. Must have the belay device securely anchored to the provided anchors or the belayer who is tied in to the provided anchors. Must not use body or hip belays.
- 8. Must be checked for ability to belay and tie in prior to participating.
- 9. Must rappel with a belay.
- 10. Must not climb below or above another climber.
- 11. YOU WILL LOSE YOUR CLIMBING/ CHALLENGE COURSE ACTIVITY PRIVILEGES BY NOT FOLLOWING THE RULES.

CAUTION:

*All who participate do so at their own risk.

*Any climbing and challenge course activity has inherent risks and may result in serious injury or death. *When you climb or participate in challenge course activities, you are responsible for taking the time to learn safe techniques, and the proper use and limitations of each piece of climbing gear.

*Climbing, rappelling, or challenge course activities are not a requirement and you may refuse to engage in any part of the activity if you feel uncomfortable about it.

I realize that climbing, rappelling/zip lining or participating on rope courses and challenge course activities are high-risk, potentially dangerous sports. I, therefore, knowingly accept this risk and agree to release Burman University, its employees and agents, and the Seventh-day Adventist Church in Canada from responsibility for any injuries which I or my child may suffer as a result of participation in climbing/rappelling/zip lining/rope courses/challenge course activities at said organization's facility.
