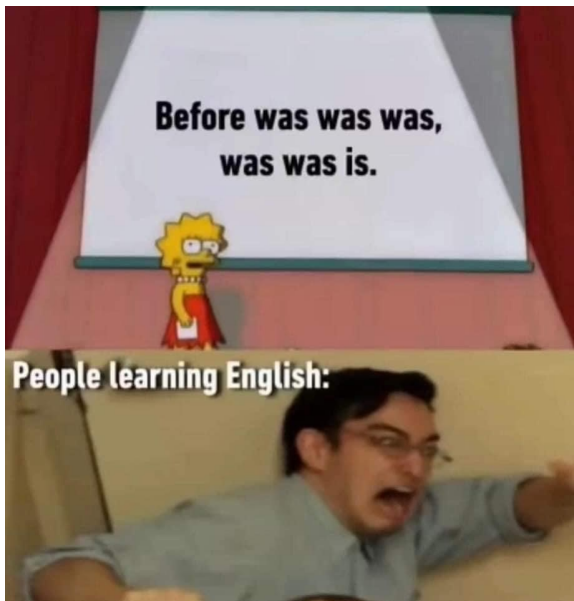

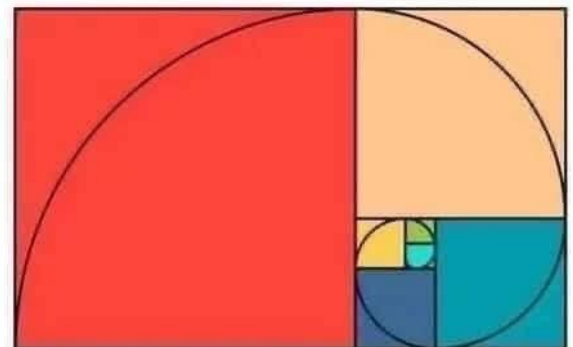

### DID YOU KNOW?

**“At the end of each fall and winter term, the Vice President for Academic Administration issues a Dean’s List that recognizes outstanding academic achievement. Students eligible for the Dean’s List will;**

- 1. have earned a minimum of 12 credits at Burman University during the term (not including S/U credits) all with grades of B or above. (CAREOnline courses are included.)**
- 2. have no incompletes, and**
- 3. have achieved a term grade point average of 3.70 or higher.”**

# Students from Alberta, Scholarships for you!

The **Dr. Gary McPherson Leadership Scholarship** recognizes students who have demonstrated outstanding leadership, especially in the area of disability.

Selection will be made on the basis of the role and contribution each student has made to the school as well as the documentation provided with the application.

- **VALUE:** \$2,000
- **Application Deadline:** January 15, 2025.

## CRITERIA:

- A Canadian Citizen, Permanent Resident, or Protected Person
- An Alberta resident according to the criteria outlined on the application
- Must be in good academic standing.
- Must be a full-time student, enrolled in a minimum of 9 credits in the current semester.
- Must have shown outstanding leadership, especially in the area of disability, and/or initiative to improve the lives of other people while attending a publicly-funded post-secondary institution in Alberta.

- a resumé highlighting your leadership involvement and extra-curricular activities related to improving the lives of other people, and
- an essay of up to a maximum of 1,000 words.

The **Laurence Decore Award** for Student Leadership recognizes post-secondary students who have demonstrated outstanding dedication and leadership to fellow students and to their community.

Selection will be made on the basis of involvement and accomplishments in student government or student societies, clubs or organizations, or student organizations at the provincial or national level, or in non-profit community organizations.

- Value: \$1,000
- Application Deadline: January 15, 2025.

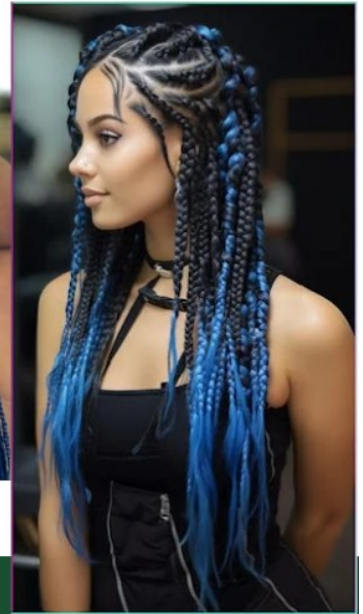

## Help students build their tax knowledge this Financial Literacy Month

November marks Financial Literacy Month in Canada, and the Canada Revenue Agency (CRA) is dedicated to helping youth boost their tax literacy. Tax literacy means knowing how to make informed tax decisions with confidence!

We believe that everyone deserves to feel empowered by understanding their taxes. It's not just about following the rules; it's about giving you the tools to manage your finances. We offer a range of tools and resources to help young people prepare for tax filing and for accessing important benefit and credit payments.

We know that taxes can feel overwhelming and confusing. Together, we can navigate the complexities and make the process simpler for students. Keep reading to learn more!

### Why should students file a tax return

Every year, students need to [file an income tax and benefit return](#) if they:

would like to receive a tax refund they may be owed

would like to receive any benefit or credit payments they may be eligible for

have to pay tax for the year

Students should still file even if they have little or no income. Depending on their income and family situation, they may be eligible to receive benefit and credit payments, such as the [goods and services tax/harmonized sales tax \(GST/HST\) credit](#).

### Claim your expenses

School can be expensive. Students may be able to claim an education-related deduction or a credit on their taxes to help!

16+ and taking post-secondary courses? Students can claim a [tuition credit](#) to reduce what they owe or they could carry it forward. They can also transfer an amount to a parent, grandparent, or spouse, which in turn can reduce their taxes.

It's a win-win!

Moved for school? Students may be able to claim [moving expenses](#) if their new home is at least 40 km closer to school.

[Paid interest on student loans](#)? Students might be eligible to claim that too, or they could carry it forward and claim it later.

### Learn about your taxes

[Learn about your taxes](#) is a free self-paced online learning tool designed to help young people understand what taxes are, how to do them, how to read a pay stub, and more. Through our 5-minute lessons and quizzes, students can get a basic understanding of what benefit and credit payments they could be eligible for. They can also check out helpful videos and infographics in our [Multimedia gallery](#).

### Start saving for your future

It is never too early to start saving! Understanding tax systems can help students plan their finances better, budget more accurately, and save more for the future.

A [Tax-Free Savings Account \(TFSA\)](#) is a great way for students who are 18 and older to save tax-free! However, it is important to remember that overcontributing to your TFSA can result in a tax of 1% for every month that the excess contributions stay in your account(s).

### Get free tax help

Need help doing taxes? Students may be able to get them done at a free tax clinic! Free tax clinics are generally offered between March and April across Canada, but many are open year-round. You can get help in person or virtually. [Find the right clinic for you](#).
